3) OB/GYN: DURING THE 2013 CHNA SURVEY PROCESS, DR. JESSICA DICKES, WAS CONTACTED AND SECURED IN DOING AN OUTREACH CLINIC ONCE A MONTH AT THE FAMC CLINIC. Note 1 - Organization and Significant Accounting Policies

Organization

Faulkton Area Medical Center (“Organization”) operates a 12-bed critical access hospital and a rural health clinic in Faulkton, South Dakota. The Organization is organized as a nonprofit corporation and is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash and cash equivalents include highly liquid investments with an original maturity of three months or less and exclude cash and cash equivalents that are included in assets limited as to use. Assets limited as to use include cash and cash equivalents held in board-designated funds and in funds restricted under a loan agreement.

Patient Receivables

Patient receivables are uncollateralized patient and third-party payor obligations. There is no interest charged on delinquent accounts. Payments of patient receivables are allocated to the specific claims identified in the remittance advice or, if unspecified, are applied to the earliest unpaid claim.

Patient accounts receivable are reduced by an allowance for doubtful accounts. In evaluating the collectability of accounts receivable, the Organization analyzes its past history and identifies trends for each of its major payor sources of revenue to estimate the appropriate allowance for doubtful accounts and provision for bad debts. Management regularly reviews data about these major payor sources of revenue in evaluating the sufficiency of the allowance for doubtful accounts.

For receivables associated with services provided to patients who have third party coverage, the Organization analyzes contractually due amounts and provides an allowance for doubtful accounts and a provision for bad debts, if necessary (for example, for expected uncollectible deductibles and copayments on accounts for which the third-party payor has not yet paid, or for payors who are known to be having financial difficulties that make the realization of amounts due unlikely). For receivables associated with self-pay patients (which includes both patients without insurance and patients with deductible and copayment balances due for which third-party coverage exists for part of the bill), the Organization records a significant provision for bad debts in the period of service on the basis of its past experience, which indicates that many patients are unable or unwilling to pay the portion of their bill for which they are financially responsible. The difference between the standard rates (or the discounted rates, if negotiated) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged off against the allowance for doubtful accounts.

The Organization's process for calculating the allowance for doubtful accounts for self-pay patients has not significantly changed from February 28, 2017 to February 28, 2018. The Organization does not maintain a material allowance for doubtful accounts from third-party payers, nor did it have significant write offs from third-party payers. The Organization has not significantly changed its charity care or uninsured discount policies during fiscal years 2018 or 2017.

Supplies

Supplies are valued at lower of cost (first-in, first-out) or net realizable value.

Assets Limited as to Use

Assets limited as to use include assets set aside by the Board of Directors for future capital improvements and debt redemption, over which the Board retains control and may at its discretion subsequently use for other purposes and assets held under loan agreements.

Interest in Net Assets of Foundation

Faulkton Area Medical Center Foundation, affiliate of the Center, solicits contributions and holds funds on behalf of the Center. The Center's interest in these funds is recorded in assets limited as to use in the accompanying financial statements. Changes in the funds held by the Foundation are recorded as changes in interest in net assets of Foundations in the accompanying financial statements.

Investments and Investment Income

Investment income or loss (including realized gains and losses on investments, interest and dividends) is included in revenues in excess of expenses unless the income or loss is restricted by donor or law. Unrealized gains and losses on investments are excluded from revenues in excess of expenses unless the investments are trading securities.

Property and Equipment

Property and equipment acquisitions in excess of \$5,000 are capitalized and recorded at cost. Equipment under capital lease obligations, if any, is amortized on the straight-line method over the shorter period of the lease term or estimated life of the equipment. Amortization is included in depreciation in the financial statements. The estimated useful lives of property and equipment are as follows:

Land improvements	3-20 years
Buildings and improvements	5-40 years

Gifts of long-lived assets such as land, buildings, or equipment are reported as additions to unrestricted net assets, and are excluded from revenues (less than) in excess of expenses, unless explicit donor stipulations specify how the donated assets must be used. Gifts of long-lived assets with explicit restrictions that specify how the assets are to be used and gifts of cash or other assets that must be used to acquire long-lived assets are reported as restricted net assets. Absent explicit donor stipulations about how long those long-lived assets must be maintained, expirations of donor restrictions are reported when donated or acquired long-lived assets are placed in service.

Impairment of Long-lived Assets

The Hospital considers whether indicators of impairment are present and performs the necessary analysis to determine if the carrying values of assets are appropriate. No impairment was identified for the years ended February 28, 2018 and 2017.

Temporarily and Permanently Restricted Net Assets

Temporarily restricted net assets are those whose use by the Organization has been limited by donors to a specific time period or purpose. Temporarily restricted net assets as of February 28, 2018 and 2017, are comprised of net assets held by the Faulkton Area Medical Center Foundation. The net assets are reflected as temporarily restricted as there is an implied time restriction on access to the funds as distributions from the Foundation are subject to approval from the Foundation board. Permanently restricted net assets have been restricted by donors to be maintained by the Organization in perpetuity. At February 28, 2018 and 2017 the Organization did not have any permanently restricted net assets.

Performance Indicator

Revenues (less than) in excess of expenses is the performance indicator and excludes transfers of assets to and from related parties for other than goods and services, and contributions of long-lived assets, including assets acquired using contributions which were restricted by donors.

Net Patient Service Revenue

The Organization has agreements with third-party payors that provide for payments to the Organization at amounts different from its established rates. Payment arrangements include prospectively determined rates, reimbursed costs, discounted charges, and per diem payments. Net patient service revenue is reported at the estimated net realizable amounts from patients, third-party payors, and others for services rendered, including estimated retroactive adjustments under reimbursement agreements with third-party payors. Retroactive adjustments are accrued on an estimated basis in the period the related services are rendered and adjusted in future periods as final settlements are determined.

The Organization recognizes patient service revenue associated with services provided to patients who have third-party payor coverage on the basis of contractual rates for the services rendered, as noted above. For uninsured patients that do not qualify for charity care, the Organization recognizes revenue on the basis of its standard rates for services provided. On the basis of historical experience, a significant portion of the Organization's uninsured patients will be unable or unwilling to pay for the services provided. Thus, the Organization records a significant provision for bad debts related to uninsured patients in the period the services are provided.

Charity Care

The Organization provides health care services to patients who meet certain criteria under its charity care policy without charge or at amounts less than established rates. Since the Organization does not pursue collection of these amounts, they are not reported as patient service revenue. The estimated cost of providing these services was approximately \$45,000 and \$35,000 for the years ended February 28, 2018 and 2017, calculated by multiplying the ratio of cost to gross charges for the Organization by the gross uncompensated charges associated with providing charity care to its patients.

Income Taxes

The Organization is organized as a nonprofit corporation as described in Section 501(c)(3) of the Internal Revenue Code, and is exempt from federal income taxes on related income pursuant to Section 501(a) of the Code. The Organization is annually required to file a Return of Organization Exempt from Income Tax (Form 990) with the IRS. In addition, the Organization is subject to income tax on net income that is derived from business activities that are unrelated to its exempt purpose. The Organization has determined it is not subject to unrelated business income tax and has not filed an Exempt Organization Business Income Tax Return (Form 990T) with the IRS.

The Organization believes that it has appropriate support for any tax positions taken affecting its annual filing requirements, and as such, does not have any uncertain tax positions that are material to the financial statements. The Organization would recognize future accrued interest and penalties related to unrecognized tax benefits and liabilities in income tax expense if such interest and penalties were incurred.

Donor-Restricted Gifts

Unconditional promises to give cash and other assets are reported at fair value at the date the promise is received. Conditional promises to give and indications of intentions to give are reported at fair value at the date the gift is received. The gifts are reported as either temporarily or permanently restricted support if they are received with donor stipulations that limit the use of the donated assets. When donor stipulated time restrictions or purpose restrictions are met or accomplished, temporarily restricted net assets are reclassified as unrestricted net assets and reported in the statement of operations as net assets released from restrictions. Donor-restricted contributions whose restrictions are met within the same year as received are reflected as unrestricted contributions in the statement of operations.

Advertising Costs

The Organization expenses advertising costs as incurred. The Organization incurred \$13,359 and \$16,517 for advertising costs for the years ended February 28, 2018 and 2017, respectively.

Note 2 - Net Patient Service Revenue

The Organization has agreements with third-party payors that provide for payments to the Organization at amounts different from its established rates. A summary of the payment arrangements with major third-party payors follows:

Medicare: (Approximately 65% of gross revenues for the fiscal years ended February 28, 2018 and 2017). The Organization is licensed as a Critical Access Hospital (CAH). The Organization is reimbursed for most inpatient, outpatient, and clinic services at cost with final settlement determined after submission of annual cost reports by the Organization and are subject to audits thereof by the Medicare Administrative Contractor (MAC). The Organization's Medicare cost reports have been audited by the MAC through the year ended February 28, 2016.

Medicaid: (Approximately 3% and 5% of gross revenues for the fiscal years ended February 28, 2018 and 2017, respectively). Inpatient acute care services rendered to Medicaid program beneficiaries are paid at prospectively determined rates per discharge. These rates vary according to a patient classification system that is based on clinical, diagnostic, and other factors. Clinical and outpatient services rendered to Medicaid program beneficiaries are reimbursed under a historical cost based reimbursement methodology. There are no retroactive settlements with the Medicaid program.

Wellmark Blue Cross and Blue Shield: (Approximately 15% and 16% of gross revenues for the fiscal years ended February 28, 2018 and 2017, respectively). Services rendered to Blue Cross and Blue Shield subscribers are reimbursed under a prospectively determined percentage of charges methodology. Clinic services are paid on fixed fee schedules.

Other Insurance Programs: (Approximately 15% and 11% of gross revenues for the fiscal years ended February 28, 2018 and 2017). The Organization has also entered into payment agreements with certain commercial insurance carriers and other Organizations. The basis for payment to the Organization under these agreements includes prospectively determined rates per discharge, discounts from established charges, and prospectively determined daily rates.

Laws and regulations governing the Medicare, Medicaid, and other programs are extremely complex and subject to interpretation. As a result, there is at least a reasonable possibility that recorded estimates will change by a material amount in the near term. The net patient service revenue for the years ended February 28, 2018 and 2017 increased approximately \$13,000 and \$1,200 due to removal of allowances previously estimated that are no longer necessary as a result of final settlements and years that are no longer likely subject to audits, reviews, and investigations.

The USDA loan agreements require funding a debt service reserve account with monthly payments of \$1,288 until the account reaches \$331,782. A deficiency in the debt service reserve account is allowable provided account funds are expended for payments on the notes payable. The reserve account balance requirement as of February 28, 2018 and 2017 was \$200,046 and \$168,332, respectively.

Note 8 - Pension Plan

Qualified employees of Faulkton Area Medical Center are covered by the South Dakota Retirement System (SDRS) which is a cost-sharing, multiple employer defined benefit pension plan administered by the State of South Dakota. The SDRS is considered part of the State of South Dakota financial reporting entity and is included in the state's financial report as a component unit. The tax ID number for the South Dakota Retirement System plan is 46-6000364 and their plan number is 001. Employees are required by state statute to contribute 6 percent of their salary to the plan. State statute also requires the employer to contribute an amount equal to the employee's contributions. Faulkton Area Medical Center contributes less than 5% of the total contributions made to the plan from all employees. As of June 30, 2017, the SDRS plan had a fiduciary net position of approximately 100% of the total actuarial accrued net pension liability. Contributions to SDRS are deposited monthly with the plan trustee who invests the plan assets. Total pension expense for the years ended February 28, 2018 and 2017, was \$281,691 and \$253,698, respectively.

Note 9 - Concentrations of Credit Risk

The Organization grants credit without collateral to its patients, most of which are insured under third-party payor agreements. The mix of receivables from third-party payors and patients at February 28, 2018 and 2017, was as follows:

Note 11 - Related Party Transactions

Faulkton Area Medical Foundation, Inc. (Foundation) is organized as a 509 (a)(3) supporting organization under IRS code regulations to hold and solicit funds for the Organization. Funds are distributed to the Organization as determined by the Foundation’s Board of Directors. The Organization’s interest in the net assets of the Foundation is reported as a noncurrent asset in the balance sheets. The amount recorded in the balance sheet is equal to the net assets held by the Foundation that are for the benefit of the Organization. During the years ended February 28, 2018 and 2017, the Organization received distributions from the Foundation in the amounts of \$32,417 and \$0-, respectively.

Note 12 - Contingencies

Malpractice Insurance

The Organization has malpractice insurance coverage to provide protection for professional liability losses on a claims-made basis subject to a limit of \$1 million per claim and \$3 million annual aggregate. Should the claims-made policy not be renewed or replaced with equivalent insurance, claims based on occurrences during its term, but reported subsequently, would be uninsured.

Litigations, Claims, and Disputes

The health care industry is subject to numerous laws and regulations of federal, state, and local governments. Compliance with these laws and regulations, specifically those relating to the Medicare and Medicaid programs, can be subject to government review and interpretation, as well as regulatory actions unknown and unasserted at this time. Federal government activity has increased with respect to investigations and allegations concerning possible violations of health care providers of regulations, which could result in the imposition of significant fines and penalties, as well as significant repayments of previously billed and collected revenues from patient services.

Note 13 - Commitments

The Organization has entered into certain long-term non-cancelable contracts resulting in purchase commitments for software maintenance and licensing and other maintenance contracts.
