2) CHEMOTHERAPY/CANCER TREATMENT: CHEMOTHERAPY/CANCER TREATMENT SERVICES WERE RESEARCHED AND ADDED TO THE EXISTING OUTPATIENT CENTER. A SMALL NUMBER OF PATIENTS HAVE BEEN RECEIVING THEIR CANCER TREATMENT AT FAMC.

THIS NUMBER HAS SEEN A GRADUAL INCREASE IN 2018.

3) OB/GYN: DURING THE 2013 CHNA SURVEY PROCESS, DR. JESSICA DICKES, WAS CONTACTED AND SECURED IN DOING AN OUTREACH CLINIC ONCE A MONTH AT THE FAMC CLINIC. SHE DID PROVIDE OUTREACH SERVICES FOR SEVERAL MONTHS, BUT LACK OF PATIENTS UTILIZING HER CLINIC CAUSED HER TO CEASE PROVIDING SERVICES IN 2015. THE 2017 CHNA AGAIN IDENTIFIED OB/GYN AS A COMMUNITY NEED. HOWEVER, BASED ON THE LACK OF UTILIZATION THAT OCCURRED WITH OUR PRIOR OUTREACH CLINIC, IT WAS DETERMINED THIS ISN'T A SERVICE OUR COMMUNITY NEEDS. FAMC IS NOT PURSUING FULFILLMENT OF THIS IDENTIFIED NEED.

4) TRANSPORTATION FOR THE ELDERLY: APPROXIMATELY 24% OF FAULK COUNTY IS AGE 65 AND OLDER. AS THE POPULATION CONTINUES TO HAVE A LONGER LIFE EXPECTANCY, TRANSPORTATION AND SAFE TRAVEL WILL UNDENIABLY BECOME A DESIRABLE ASSET TO OUR COMMUNITY. THIS PROGRAM WAS ORIGINALLY EVALUATED BY THE FAULKTON DEVELOPMENT CORP. THE FAULK COUNTY COMMUNITY TRANSIT AUTHORITY HAS BEEN FORMED AND IS MOVING TOWARD THE GOAL OF PROVIDING COMMUNITY TRANSPORTATION WITH A 12 PERSON BUS.

IN NOVEMBER 2017, A NEW OUTPATIENT/INFUSION CENTER WAS COMPLETED AND OPENED. THIS HAS BEEN IN THE PLANNING AND IMPLEMENTING STAGES SINCE THE 2013 CHNA SURVEY AND RESULTS.
